**COURSE DESCRIPTION:**

Special Topics course EDCD 797.005: Supervision Issues in Career Counseling provides students with an overview of supervision issues related to career counseling practice. Students will learn about supervision theories and assist with supervising students in the EDCD610 Career and Educational Counseling course.

**NATURE OF COURSE DELIVERY:**

**Course delivery will include individual one-on-one discussions, class participation, and off site supervision.**

**LEARNER OUTCOMES:**

1. Gain a understanding of supervision issues and theories in the counseling field.
2. Acquire comprehensive literature review skills in a specialized area.
3. Experience role of “supervisor” by assisting EDCD610 students with their service learning projects.

**Relationship to Course and Program Goals and Professional Organizations**

EDCD 797 is a special topics course and meets the requirement that all masters students take 2-3 credits of special topics course work. This 2-credit course will contribute to counseling students' knowledge of a particular population of clients.

EDCD 797 fulfills the requirements of the following professional organizations:

- Virginia Department of Education requirement for school counseling licensure that candidates understand the knowledge, skills and processes of individual counseling.
- Virginia Department of Health Professions requirement that Licensed Professional Counselor candidates complete graduate study in theories and techniques of counseling and psychotherapy.
- Council for the Accreditation of Counseling and Related Educational Programs (CACREP) core requirement described in Section II.K.e: Helping relationships: An understanding of counseling and consultation processes.
- American Counseling Association Code of Ethics requirement that counselors establish counselor education and training programs that integrate academic study and supervised practice.

**REQUIRED TEXTS:**

Selected articles assigned by instructor and selected by students. See Blackboard for assigned articles.

**COURSE REQUIREMENTS:**

- **Active Participation** is expected in all class activities. Students are expected to attend all classes and come to class prepared having completed all reading and written assignments. Active participation is based on your presence in the class—one or more unexcused absence may result in course failure. **[20 points]**.
- **Research Summary.** Student will summarize 5-7 articles based on supervision issues/theories in counseling. **[20 points]. Reading summary due 3/28/11.**
- **Active Service Learning Project Supervision.** Students will assist ED610 students with development, implementation, and supervision of service learning projects. Students will also assist instructor with evaluation process of students. **[30 points]**.
- **Reflection Paper.** Paper should be 8-10 pages and should provide a reflection of student’s experience in the class including work with students, supervision of SLP, and role as supervisor. **[30 points]. Reflection Paper due 5/10/11.**
