#### UNIVERSITY CATALOG COURSE DESCRIPTION

Discusses theories and concepts in sports analytics. Topics cover player performance, player management, sports data strategies, team management, and game-day operations and strategies.

## COURSE OVERVIEW AND LEARNING OBJECTIVES

This course prepares students to gain an appreciation and knowledge of sport management while analyzing the strategies and concepts that are apparent within today's industry. At the conclusion of this course, students will be able to:

- 1) Analyze the concepts and characteristics of analytics in sports today.
- 2) Successfully interpret the aspects of analytics in sports today, i.e. impact of analytics in sports, player data, player data points, performance data tracking, etc.
- 3) Comprehend and engage in critical thinking with the analytic topics in sports today, while analyzing the importance of these aspects toward players, coaches, teams, etc.
- 4) Obtain a unique perspective of the growing trend and field of sports analytics, while recognizing the reasons for doing so within sports today.
- 5) Absorb and gather insight on the strategies and concepts being used today to evaluate player/team performance related to sports analytics.
- 6) Comprehend and effectively analyze the different trends of sports analytics today, while assessing the outcomes and concepts of the impact within the sports analytics field.

## **COURSE DELIVERY METHOD**

This course will be delivered online using an asynchronous format via the Blackboard learning management system (LMS) housed in the MyMason portal. You will log in to the Blackboard course site using your Mason email name (everything before "@masonlive.gmu.edu) and email password. The course site will be available online on August 20, 2023, at midnight.

## TECHNICAL REQUIREMENTS

To participate in this course, students will need to satisfy the following technical requirements:

- High-speed Internet access with a standard up-to-date browser, either Internet Explorer or Mozilla Firefox is required (note: Opera and Safari are not compatible with Blackboard).
- Students must maintain consistent and reliable access to their GMU email and Blackboard, as these are the official methods of communication for this course.
- Students may be asked to create logins and passwords on supplemental websites and/or to download trial software to their computer or tablet as part of course requirements.

#### **EXPECTATIONS**

- Course Week: Because asynchronous courses do not have a "fixed" meeting day, our week will start on Monday morning at 5:00 am, and finish on Sunday night at 11:59 pm
- Log-in Frequency: Students must actively check the course Blackboard site and their GMU email for communications from the instructor, class discussions, and/or access to course materials at least five times per week.
- Participation: Students are expected to actively engage in all course activities throughout the semester, which includes viewing all course materials, completing course activities and assignments, and participating in course discussions and group interactions.
- Technical Competence: Students are expected to demonstrate competence in the use of all course technology. Students who are struggling with technical components of the course are expected to seek assistance from the instructor and/or College or University technical services.
