Course Description

Examines the complexity of language acquisition and literacy development. Focuses on typical and atypical language development, connections between language and literacy, and diversity of communication styles in families and cultures. Emphasizes first and second language acquisition. Field experience required.

Course Overview

EDSE 467 examines the development of literacy and language skills for individuals with and without disabilities, and focuses on how individuals learn to read and on how modifications and adaptations can provide literacy and language learning opportunities for individuals with severe disabilities. The connections between the diversity of communication styles in families and cultures, as well as first and second language acquisition, are emphasized.

- 4. Demonstrate an understanding of components of typical literacy and language acquisition, including concept of print, explicit phonics instruction, syllables, morphology and phonology, fluency, and vocabulary development.
- 5. Demonstrate an understanding of how syntax and semantics interact in the construction of meaning in literacy and its relationship to reading comprehension.
- 6. Demonstrate an understanding of the relationship of on-going assessment and the planning of reading instruction.
- 7. Identify and implement a variety of early reading comprehension strategies.
- 8. Identify and implement strategies and activities that foster an appreciation of a variety of literature and independent reading including fiction and non-fiction.
- 9. Demonstrate knowledge of best practices and strategies in reading instruction for individuals with severe disabilities as outlined in the Virginia English Standards of Learning.
- 10. Demonstrate knowledge of writing strategies and conventions to support composition.
- 11. Demonstrate understanding of the mechanics of written expression including proficiency in understanding the stages of spelling development and the writing process.

Field Experience Requirement

A field experience is a part of this course. A field experience includes a variety of early and ongoing field-based opportunities in which candidates may observe, assist, and/or teach. Field experiences may occur in off-campus settings, such as schools (CAEP, 2016). Below are REQUIRED PROCEDURES FOR ALL STUDENTS ENROLLED IN THS COURSE.

1. Complete the online EDSE Field Experience form. This online form will be sent to your GMU email from EDSEfld@gmu.edu on the first day of the semester. Click on the link and complete the form as soon as possible. ALL students should complete the form, regardless of whether you need assistance in locating a field experience placement or not. This information is required by the state. Please direct any questions about the form to Dr. Kristen O'Brien at EDSEfld@gmu.edu.

If you are a full-time contracted school system employee and will complete the field experience at your worksite with administrator and instructor approval, you will be asked to specify the school at which you will be completing the field experience.

If you request a field experience placement to be arranged, you will receive information via your GMU email about your assigned placement from the Clinical Practice Coordinator in the College's Office of Teacher Preparation. Check your GMU email regularly for important information regarding your field experience. Follow all instructions for the necessary Human Resource (HR) paperwork required to access the assigned field experience placement. Note that you may NOT arrange your own field experience placement.

2. View the EDSE Field Experience Introduction presentation. On the first week of classes and prior to representing George Mason in off-campus settings, your instructor will show a video presentation or provide a link to the presentation, which includes important information about the registration process for EDSE field experiences and tips for a successful field experience. After the presentation, sign the document provided by your instructor to indicate that you have

watched the presentation and are aware of the EDSE field experience professionalism expectations.

- 3. Document your field experience hours. Your instructor may provide you with access to field experience documentation forms to use in documenting the hours and activities completed in your field experience placement. Your instructor will provide more directions on how to use and submit the documentation form.
- 4. Complete the field experience end-of-semester survey. If you complete your field experience at a placement arranged by GMU, towards the end of the semester, you will receive an email from EDSEfld@gmu.edu with a link to an online survey. This brief survey asks you to report about important features of your field experience placement.
- 5. If you believe you need ADA accommodations during your field placement and/or internship experience, please contact Mason's Disability Services office (DS). Specific accommodations for fieldwork and internships may be different than academic accommodations; however, like academic accommodations, they are not retroactive. Connecting with DS is a student-initiated interactive process. DS will collaborate with the department and possibly the placement site to provide reasonable accommodations that are individualized and based on documentation, functional limitations, and a collaborative assessment of needs. Other Assignments

- 1. Literacy Case Study (100 Pts): This is your VIA and College-wide assessment assignment (A full description will be presented in Canvas) The goal of this assignment is for you to demonstrate your knowledge of the different pillars that make up a good literacy curriculum, how to teach them, and your ability to apply these to a single student. The literacy case study requires you to do observations of a target student in order to complete the 8-10 page (minimum) paper using APA formatting and paper. The paper is divided into three parts:
 - **a. Part one:** Student's literacy History and current level of functioning.
 - **b.** Part two: Literacy plan for the student including a goal and full-bodied curriculum plan, evaluation plan and AT needed.
 - **c. Part three:** References and appendix. You will be including all of your lesson plans to the appendix when you upload this assignment. You will also be heavily graded on how well you use your texts and the articles and lectures to ground your plan in research and EBP's.
- **2.** Lesson Plans: Four lesson plans at 50 points each for a total of 200 points possible As we cover different elements of literacy you will be asked to turn in lesson plans. Each lesson plan is worth 50 points. Each lesson plan has a different due date.

Detailed descriptions of the directions for each lesson plan is found on blackboard under the Assignments tab. Graduate students, please use the *graduate student template and rubric*. Undergraduates, please use the *undergraduate template & rubric*.

3. Comprehensive Exam: 75 points

This test will cover all of the blocks of literacy covered in this course to include knowledge of what each area covers and how to apply the skills to students with severe disabilities. Questions will cover the readings, the lectures and discussion topics, and lesson plan feedback covered in class. Exam is open note and open book and you will have a week to complete it.

4. Group Participation: 5 points per week up to 13 weeks for a total of 65 points
Each week during class time, there will be discussion and activities done in class which
are based upon the lectures and readings done prior to class time. These activities are
designed to be done in a group setting and with real time feedback from the
instructor. These activities may NOT be made up. If you miss class entirely, arrive
late, after the activity has been completed or leave early before or during the activity,
then your grade for that day is 0. There are no exceptions for this.

5. Reading Check/ Canvas Lecture Pre-Class Activity: 60 points (5 points per week for 12 weeks)

Each week that you are assigned to watch pre-recorded lectures and read articles or text chapters, you will be required to complete a Pre-Class Activity. This activity will be part of the module. These 5-point activities will be available throughout the week that the module is open but are due by 5:00 PM the night of our synchronous course every Wednesday. All modules open Wednesdays at midnight and you will have an entire week to complete the readings, lectures and Pre-class Activity. No late submissions will be accepted.

Professional Dispositions

Throughout study in the College of Education and Human Development, students are expected to demonstrate behaviors that reflect the positive dispositions of a professional. Professional dispositions are an essential function of a special educator's job, indicating that these dispositions are critical to develop and assess in special education licensure programs. In the College of Education and Human Development, dispositions are formally and separately evaluated in VIA/SLL at least three points in each student's program – a self-evaluation at the start of their program, a self-evaluation at the mid-point of their program, and a university supervisor's evaluation during internship. In special education undergraduate licensure programs, the initial self-evaluation is completed in designated courses (EDSE 241, EDSE 361, EDSE 311), the midpoint self-evaluation is completed in designated courses (EDSE 445, EDSE 465, and EDSE 419), and the internship evaluation is completed by instructors in EDSE 482, EDSE 483, and EDSE 484. In addition to these three designated evaluation times, students, instructors, and/or mentor teachers may complete program disposition assessments as part of other courses. Instructors and mentor teachers may complete observer-rated disposition assessments other times throughout the program, as needed. When dispositions are assessed, it is important that for areas where a positive disposition is rated as "not proficient," the student takes steps to grow as an educator.

Use of Generative AI

Generative AI tools should follow the principles of Mason's Academic Standards. This includes being honest about the use of these tools for submitted work and including citations when using the work of others, whether individual people or Generative AI tools.

Other AI Information

Generative AI (GenAI) tools have limitations: they can hallucinate (create incorrect statements and provide fake citations), create inaccurate code, and provide offensive images or examples. They have been trained on limited sources that may contain biases and create biased output. The use of these tools creates other ethical quandaries: the algorithms rely on work done by other humans and do not give credit to their sources, and the algorithm adjustments are often

completed by workers who may not be fully compensated for their labor and emotional stress. Lastly, reliance on these tools may stifle your own creativity and impede the learning process. Your decision to use Generative-AI tools should always consider these limitations.

If you do not understand what you are asking the AI generator to write, then you will not understand what it wrote and whether what it wrote is correct. Be advised.

Who owns the right to materials used with GenAI tools — including original student work submitted to a GenAI program—is currently unclear. If you do not wish to risk (or give up) the rights to your intellectual property, you should consult your instructor
