Current Research

- *Crisis Preparedness and Response in Schools and Communities:* The first phase of this study will utilize a descriptive design to explore resources, interventions, and protocols employed by school personnel (administrators, teachers, school counselors, and school psychologists) to respond to school-based crises. Participants will be asked about the efficacy of these resources/interventions/protocols in helping impacted individuals recover, as well as, mitigation efforts of the school system/school personnel to prepare for and mitigate additional crises. Phase two of this research will utilize the same methodology, but investigate community based mental health organizations. *Research team: Stephanie F. Dailey (primary) and Maggie Parker*
- *Disaster Mental Health Counseling Competencies:* In collaboration with the American Counseling Association Crisis, Disaster, and Trauma Counseling Task Force, this investigation aims to produce one of three independent sets of evidence-informed, skill-based competencies for disaster mental health (DMH) counseling. This project employs a content analysis of existing literature on core skills for DMH counselors, focus groups of active DMH counselors, and a Delphi panel. Focus groups will ensure the competencies are generated within a real-world clinical framework and the Delphi panel will iteratively consolidate expert opinion. Competencies will be presented to the American Counseling Association Governing Council in Fall 2019 for endorsement and follow up studies to validate the competencies are planned for Spring 2020.
- *Shelter-in-place and mental health following the Boston Marathon bombing:* Using a mixed-methods sequential explanatory design, this study investigated the impact of the 18-hour shelter-in-place (SIP) mandate on residents within Boston and surrounding communities following the Boston Marathon bombing. In the first phase of the study, 164 participants completed a mental health and post-traumatic growth inventory. Phase two of the study included standardized open-ended interviews with 21 individuals about their experience. These interviews collected in-depth information pertaining to the participants' experience with the SIP order to supplement findings. *Research team: Stephanie F. Dailey (primary), Tara S. - *Real life values conflicts: Ethical decision-making in practice:* Using a consensual qualitative approach, this research identifies actual ethical decision-making practices used by counselors experiencing values conflicts in their work. This investigation will identify how professionals identify values conflicts as well as their actual decision-making process. *Research team: Harriet L. Glosoff (primary), Stephanie F.
